I/we agree to handle, pack, process, and move regulated articles in accordance with applicable plant quarantines; use all permits and certificates in accordance with instructions; maintain and offer for inspection such records as may be required, and abide by the following stipulations:

- All plants, or a representative number thereof, moved under nematode certification number 3060 must have been sampled by the Division of Plant Industry (the "Division") and found to be negative for all prohibited nematodes.
- Nematode-certified and non-certified plants are not to be commingled in the nursery or in shipments to regulated States.
- Potting medium/soil must be stored in a manner approved by the Division.
- Plants and/or plant parts from foreign sources will not be sold under nematode certification number 3060 until received or "grown-out", sampled and approved by the Division.
- Sanitation practices will be maintained as approved by the Division.
- Plants from other Nematode certified nurseries in the State must not be moved under certification number 3060, but may be moved when accompanied by the producing nurseries nematode certification and/or consolidation forms.
- Violation of any stipulation of this agreement is grounds for suspension and may result in prosecution as provided by Section 581.141 and 581.211 Florida Statutes.
