I/we agree to handle, pack, process, and move regulated articles in accordance with applicable plant quarantines; use all permits and certificates in accordance with instructions; maintain and offer for inspection such records as may be required; and abide by the following stipulations:

- 1. To ship only nursery stock (including sod) into North Carolina that is free from Tropical Spiderwort (Commelina benghalensis L.)
- 2. Any nursery production areas or shipments found with Tropical Spiderwort (Commelina benghalensis L.) will be cause for this agreement to be canceled and any certificates revoked.
- 3. To permit authorized representatives of the FDACS to access and review records pertinent to this agreement
- 4. All certificates issued under the authority of this agreement shall remain the property of the FDACS and shall be relinquished upon request
- 5. The intent of this agreement is to facilitate the shipment of regulated articles into North Carolina without individual signed certificates of inspection.
- 6. This agreement does not preclude North Carolina agriculture inspection of shipments at destination.
- 7. Violation of any stipulation of this agreement is grounds for suspension and may result in prosecution as provided by sections 581.041 and 581.011, Florida Statutes.
- 8. This agreement will expire two years from the date of issue
